**THE POSITION**

Under direction, to perform professional legal work in the Office of the District Attorney.

**There are four levels of Attorney in the District Attorney's Office. Candidates who are referred for interview will be assessed as to the appropriate level if a job offer is made.**

**Attorney I requires active membership in the California State Bar upon appointment.**

The salary for Attorney I is \$55.03 - \$57.79 hourly, \$4,402.40 - \$4,623.12 biweekly, \$9,538.53 - \$10,016.76 monthly, and \$114,462.40 - \$120,201.12 annually.

**Attorney II requires active membership in the California State Bar upon appointment, and one year of experience as an Attorney I with Santa Clara County, or two years of experience in the full time practice of law in a government agency or in private practice.**

The salary for Attorney II is \$64.53 - \$70.09 hourly, \$5,162.32 - \$5,607.36 biweekly, \$11,185.03 - \$12,149.28 monthly, and \$134,220.32 - \$145,791.36 annually.

**Attorney III requires active membership in the California State Bar upon appointment, and two years of experience as an Attorney II with Santa Clara County, or four years of experience in the full time practice of law in a government agency or in private practice.**

The salary for Attorney III is \$77.11 - \$85.01 hourly, \$6,168.40 - \$6,800.48 biweekly, \$13,364.87 - \$14,734.37 monthly, and \$160,378.40 - \$176,812.48 annually.

**Attorney IV requires active membership in the California State Bar upon appointment, and two years of experience as an Attorney III with Santa Clara County, or six years of experience in the full time practice of law in a government agency or in private practice.**

The salary for Attorney IV is \$93.74 - \$116.67, \$7,499.04 - \$9,333.84 biweekly, \$16,247.92 - \$20,223.32 monthly, and \$194,975.04 - \$242,679.84 annually.

**Upon appointment, candidates must either possess a valid California's Driver's License or an ability to utilize an alternative method of transportation to carry out essential job-related functions.**

**Eligible candidates must pass a background investigation to qualify for employment.**

### **EMPLOYMENT STANDARDS**

Active membership in the California State Bar is required upon appointment.

\* Experience as an attorney in a District Attorney's Office in another public agency may be considered equivalent for appointment or promotion in the corresponding District Attorney's Office in the County of Santa Clara.

Knowledge and abilities consistent with the highest standard of the legal profession and with the level of difficulty and expertise required for the intended appointment.

**VETERANS PREFERENCE INFORMATION:** Any veteran who has submitted a copy of their DD214 form, and received a discharge of other than dishonorable, from the armed forces showing service in any branch of the United States military will be given a preferential credit of five percent (ten percent for those identified as disabled veterans), after attaining a passing examination score for a numerically scored examination, as applicable by Memorandum of Understanding.

**THE EXAMINATION PROCESS:** The examination process may include one or more of the following: application review, application appraisal, preliminary competitive rating, performance test, written test, and/or oral interview examination.

This recruitment may require completion of Supplemental Questions in order to evaluate your education, training and experience relative to the required knowledge and abilities for the position you are applying for.

Your responses to the questions may also be reviewed and scored in a Competitive Rating evaluation process based on pre-determined rating criteria.
